

Resolution No. JPA 20-4

RESOLUTION ADOPTING A PUBLICLY AVAILABLE PAY SCHEDULE FOR
THE ALAMEDA CORRIDOR TRANSPORTATION AUTHORITY

WHEREAS, the Alameda Corridor Transportation Authority (“ACTA”) has a pay schedule that establishes pay ranges for each officer and employee position; and

WHEREAS, the pay ranges for ACTA’s officer and employee positions conform with selected equivalent staff positions within the City of Los Angeles employment system; and

WHEREAS, from time to time, the pay ranges for the equivalent staff positions at the City of Los Angeles are modified pursuant to negotiated Memorandums of Understanding (“MOUs”) between the City and various employee collective bargaining units; and

WHEREAS, the equivalent City of Los Angeles staff positions had pay range increases effective either July 7, 2019 or January 20, 2020 per their respective negotiated City MOUs; and

WHEREAS, it is the practice of ACTA to automatically modify its pay schedule whenever such City of Los Angeles employee pay ranges change; and

WHEREAS, the California Public Employees Retirement System requires the governing body of each participating agency to adopt its respective pay schedule that conforms to the requirements of a publicly available pay schedule as set forth in Title 2 of California Code of Regulations, Section 570.5; and

WHEREAS, the modified pay schedule showing each of ACTA’s officer and employee titles and minimum and maximum pay ranges by annual and hourly amounts is set forth in Exhibit A, attached to this Resolution.

NOW THEREFORE BE IT RESOLVED that the Governing Board of ACTA does hereby approve and adopt the publicly available pay schedule as set forth in the attached Exhibit A to be effective from January 20, 2020;

BE IT ALSO RESOLVED that the salary schedule will be posted on the ACTA website, and will be made available for public inspection for not less than five (5) years.
