FIRST AMENDMENT TO AGREEMENT NO. C0868 BETWEEN THE ALAMEDA CORRIDOR TRANSPORTATION AUTHORITY AND TETRA TECH, INC.

This FIRST AMENDMENT to Agreement No. C0868 is made and entered into by and between the ALAMEDA CORRIDOR TRANSPORTATION AUTHORITY, a California Joint Powers Authority ("ACTA") acting by and through its Governing Board ("Board"), and TETRA TECH, INC., a Delaware corporation ("Consultant").

WHEREAS, an Agreement between ACTA and Consultant was entered into, effective October 10, 2017. The Agreement is effective through June 30, 2020 for a not-to-exceed amount of \$150,000 for professional, scientific, expert and technical consulting services for environmental site assessments and restoration on property under the management and control of ACTA; and

WHEREAS, at its February 12, 2020 meeting, ACTA's Board approved a three-year extension of the agreement through June 30, 2023.

NOW, THEREFORE, IT IS MUTUALLY AGREED AS FOLLOWS:

- 1. Section 4.2 is hereby amended to extend the term for an additional three (3) years through June 30, 2023.
- 2. Exhibit D. is hereby amended to add Exhibit D-1, which outlines the rates to be utilized for the additional three (3) years through June 30, 2023.
- 3. Except as amended in Items 1 and 2 above, all remaining terms and conditions of Agreement No. C0866, remain in full force and effect.
- 4. The effective date of this amendment shall be the date of its execution by ACTA's Interim Chief Executive Officer.
