FIRST AMENDMENT TO AGREEMENT NO. C0866 BETWEEN THE ALAMEDA CORRIDOR TRANSPORTATION AUTHORITY AND COURTNEY TORRES CONSULTING, INC.

This FIRST AMENDMENT to Agreement No. C0866 is made and entered into by and between the ALAMEDA CORRIDOR TRANSPORTATION AUTHORITY, a California Joint Powers Authority ("ACTA") acting by and through its Governing Board ("Board"), and COURTNEY TORRES CONSULTING, INC., a California corporation ("Consultant").

WHEREAS, ACTA and Ek Torres and Molina, Inc., a California corporation, entered into Agreement No. C0866 effective July 1, 2017 through June 30, 2020, with an optional three-year extension for professional, expert and technical consulting services related to media relations support for ACTA in an amount not-to-exceed \$250,000; and

WHEREAS, Ek Torres and Molina, Inc. was dissolved and a Consent to Amendment and Assignment and Assumption of Agreement between ACTA and Consultant was entered into effective March 1, 2019; and

WHEREAS, at its February 12, 2020 meeting, ACTA's Board exercised the three-year extension option to extend the term of the agreement through June 30, 2023 and approved an increase in the compensation amount by \$250,000 for a total not-to-exceed amount of \$500,000.

NOW, THEREFORE, IT IS MUTUALLY AGREED AS FOLLOWS:

- 1. Section III. <u>EFFECTIVE DATE AND TERM OF AGREEMENT</u> is hereby amended to exercise the option to extend the term of the Agreement for an additional three (3) years through June 30, 2023.
- Section IV. <u>COMPENSATION AND PAYMENT</u> Item B. is hereby amended to provide an increase of \$250,000 for a new maximum amount payable under the Agreement of Five Hundred Thousand Dollars (\$500,000).
- 3. Except as amended in Items 1 and 2 above, all remaining terms and conditions of Agreement No. C0866, remain in full force and effect.
- 4. The effective date of this amendment shall be the date of its execution by ACTA's Interim Chief Executive Officer.
