

**THIRTEENTH AMENDMENT TO AGREEMENT NO. C0783
BETWEEN THE ALAMEDA CORRIDOR TRANSPORTATION AUTHORITY AND
IBI GROUP LTD.**

This **THIRTEENTH AMENDMENT** to Agreement No. C0783 is made and entered into by the **Alameda Corridor Transportation Authority ("ACTA")**, and **IBI Group Ltd.**

WHEREAS, an Agreement between ACTA and IBI Group Ltd. (IBI) was entered into commencing February 1, 2007 through June 30, 2008 for a not-to-exceed amount of \$250,000 for special professional services and system enhancements related to ACTA's Revenue Assessment and Verification System (RAVS); and

WHEREAS, twelve amendments were subsequently issued which added services, increased the amount of consideration and extended the term of the contract; and

WHEREAS, at its March 14, 2019 meeting, ACTA's Governing Board approved an extension of the term of Agreement No. C0783 by six months, from July 1, 2019 through December 31, 2019 and increased the compensation amount by \$180,000 for additional services for a total not-to-exceed amount of \$670,000.

NOW, THEREFORE, IT IS MUTUALLY AGREED AS FOLLOWS:

1. Section 3.1, the term of the Agreement, is hereby amended to extend the term by six months through December 31, 2019.
2. Attachment D, as referenced in Section 2.1, shall be amended to provide an increase in total compensation of \$180,000 for a new NTE amount of Six Hundred Seventy Thousand Dollars (\$670,000).
3. Attachment D-1, adding certain services, schedule and hourly rates, is attached hereto and made a part hereof.
4. Except as amended herein, all remaining terms and conditions of Agreement No. C0783, remain in full force and effect.
5. The effective date of this amendment shall be the date of its execution by ACTA's Chief Executive Officer or Chief Financial Officer.
