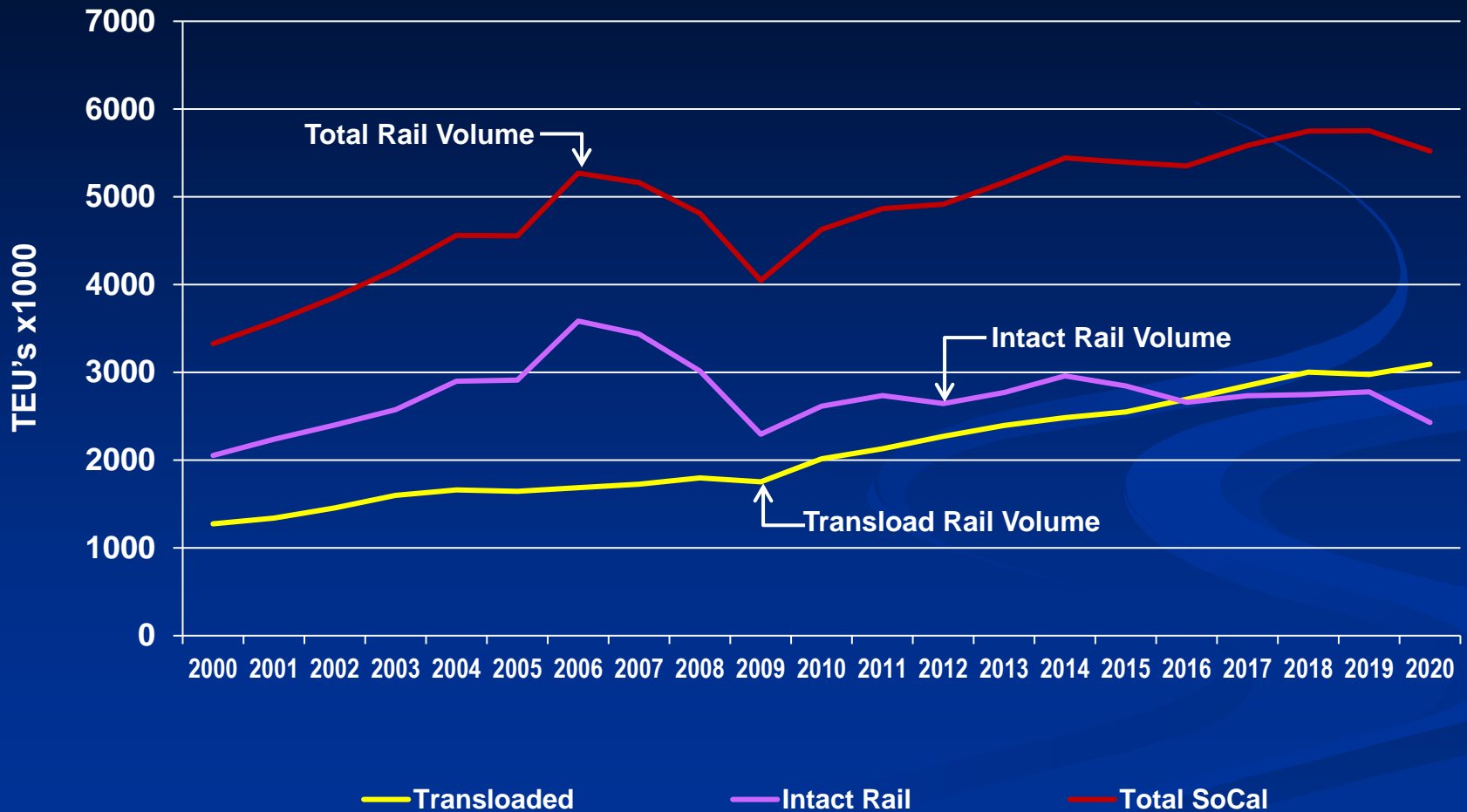

LA/LB Import Rail Volumes

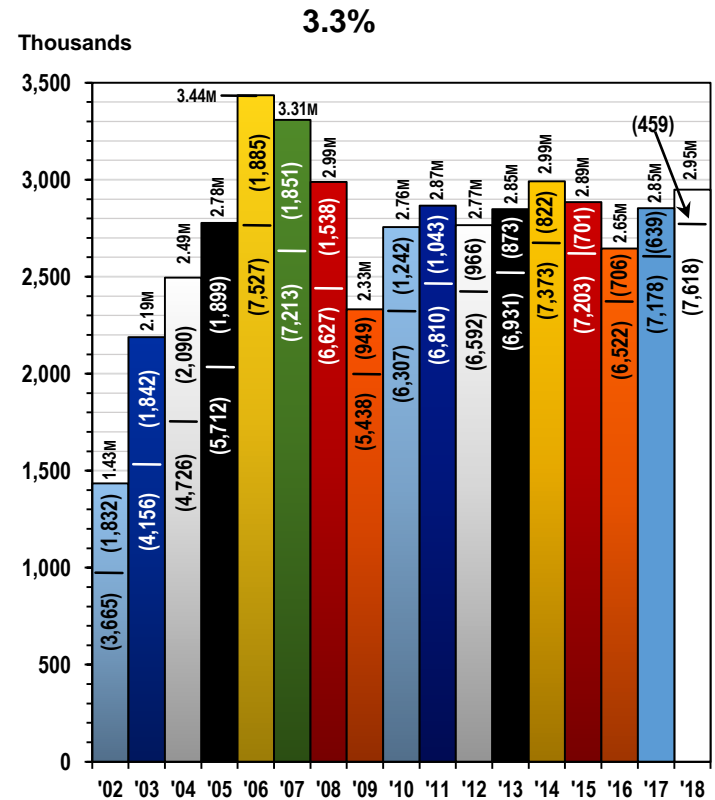
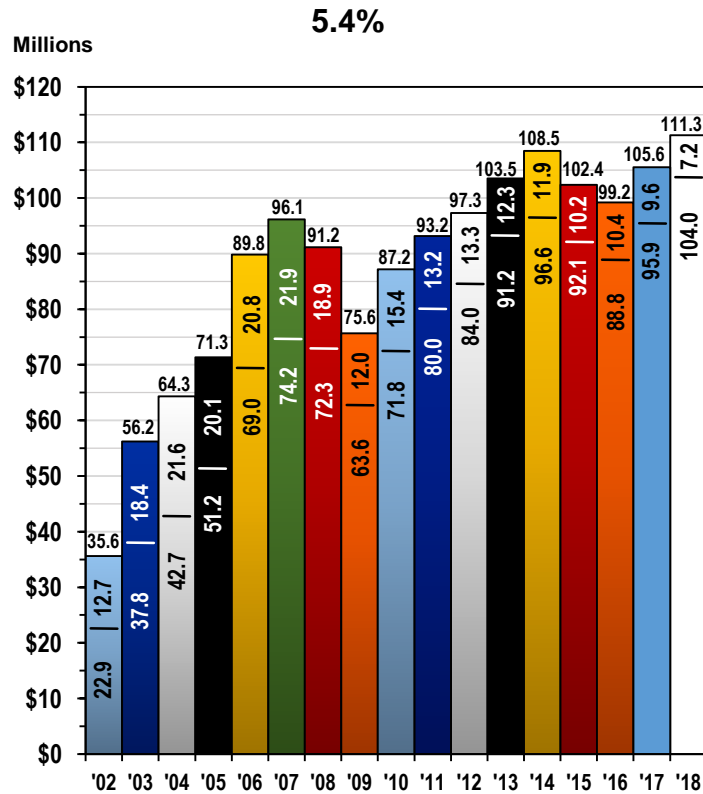


Annual Performance Comparison
